Resale rights products are considered to be the easiest ways to make money online. The only work you have to do is, buying the product and its resale right, loading it on your website and selling it. You can make money with the help of resale rights products in two ways:

First method is purchasing the resale rights of someone else's product and enjoying 100% profit when it is sold.

Second method is selling the resale rights to other interested sellers and keeping 100% profit with you.

In order to be successful, it is essential to understand the different resell right types and what you can do with them.

Basic resell rights:

The right for reselling the product is only given to the seller and the customer of that product cannot sell it to someone else. 100% profit remains with the seller.

Private label rights:

Private label rights is considered to be the holy grail of all resell rights. When a seller purchases this right, he or she is free to make any desired changes in the product. They can put their own name on it, sell master or basic rights to the product or sell it for profit. Sellers don't have to spend hours to create a product and they are free to manage it the way they want.

Master resale rights:

The seller not only gets the right for reselling the product but also to resell the product's basic resell rights. So, if a customer purchases basic resell rights of a product, he or she can make profit by then selling it to someone else.

Royalty rights:

Under royalty rights, sellers will have to pay a percentage to the author or owner of the product for every e-book they sell.

Give away rights:

Give away rights means that a seller can give away the product to anyone for free, but no resale or editing can be done to it.

As a seller once you get the product you must start studying your competitors. You need to know what strategies they are implementing so that you do something different and better. More incentives and bonuses can be thrown in for making an offer attractive to potential customers. This is necessary because online customers are used to shopping by comparison and if your deal is good you can make a lot of money.

Regular Resale Rights

are where you buy the product with a license to sell the product to others from your sales page. You sell only the product and not the license to resell the product. Here you make only a small commission.

Master Resell Rights

In this you are permitted to sell both the product and the license to resell the product to your customer who in turn can sell both the product and the license to their customers. In this system, you get to keep 100% of the profit.

Private Label Rights

In this you get the right to sell the product or ebook along with the resale license. You can also change the content add your own title, customize the pages and present it as your own new title, these conditions make it extremely attractive.

Choosing the right ebook or product with the desired resale package is crucial as it may look like a brilliant title but other people might be offering the same title free bundled with some other product. This calls in for good research before jumping into the fray. It is not that you won't be able to sell your product. It only means that it will be difficult to sell something that is already available on the net for free.

Set up a sales page

Giveaway Ebooks resale rights

Your customers can only use the ebook personally and not resale it to someone else. You cannot brand or edit the ebooks in this type of resale rights.

Master ebook Resale Rights

In this type of resale right, you can resell the ebook and keep the entire profit as well as pass on the resale rights to the customers. Master ebook resale right leaves you with two categories of customers, one who will buy the ebook from you for personal use and some who will buy to resell it. Master ebook resale rights are a better option to earn more money. You can sell the ebook at a nominal rate to the end user and charge a higher price to the business customer. However, these rights normally do not allow editing and branding of the ebooks.

Private Label Resale Rights

Private label resale rights prove more beneficial to earn money in the resale business. These rights allow you to brand and edit the content. You have complete authority to handle the ebook your way. You have the choice to choose any method of sale. You get the authority to even sell the rights.

Ebook branding rights

These types of rights will help the author earn commission once the customer purchases the product by clicking on the link. If the ebook is brandable, you can replace the links with your own links and earn commission.

Free resale rights for an e-book can open sources of income for those who purchase the rights and also for those who sell these rights for free. Lets us first get to know what resale rights are and how the people who buy these rights can profit from them.

Limitations

Publishing houses show only temporary interest in subjects that are not necessarily main stream. This has driven more and more writers to seek refuge in online publishing. This could be a stepping-stone for aspiring writers towards a more fulfilling and profitable career in creative writing.

Some last useful tips:

- The topic should be interesting to a large number of readers, relevant to the times we are living in, and should be broken down into sub-topics to be dwelt in detail in separate chapters.
- Generally self help topics, how to guides and manuals are a good starting point. Thorough research in the chosen subject is the first prerequisite in writing a great book.
- Use easy to understand language, cut out the jargon, as not everybody understands them.
- Include good quality relevant graphics to illustrate the point you are trying to make.

- The cover page should be eye-catching and should ignite the urge to read or have the book in ones collection.
- The content of the book should live up to its title; it should be intriguing informative and make readers want more and more of it.
- Attach a tastefully done thank you page.

Now the most important part:

- Attach the resale right to your book; this will generate passive income for you later.
- Attaching full resale rights will enable you to sell your e-book to your clients who in turn will have to repurchase the resale right from you to book profits.
- Package yourself as a brand with your picture, and a catchy slogan.
- Find affiliates who will compliment your product and not compete.
- Do a complete makeover of the WebPages, add your own content and express yourself creatively in such a way that readers can relate to what you have to say.
- Keep reinventing yourself as a brand so that you stand out from other competitors trying to do the same. This could take a while but if you have done your research well and branded yourself, your credibility as e-book marketer will grow.

Creating your own products or acquiring private label rights of well known products and repackaging them diligently will ensure you are on your way to owning a profitable internet business.
